Police Report

There was no Police report.

Partnership Report

An update was given on the Burnhope Miners Gala Centenary event :-

- The event Planning Group is to work with the Partnership.
- A commemorative issue of the Burnhope Wheel is to be produced
- Local businesses to be approached regarding sponsorship. In return they would receive free advertising in the Burnhope Wheel.

Cllr McCormick reported on assistance given finding an allotment site for a local resident.

Permissive footpaths - Burnhope Morrow Edge and Burnhope Stream Valley

Mrs Galloway updated the meeting on her attempts to have the above permissive footpaths converted to Public Rights of Way by Durham County Council. In November 2023 she submitted information in support of this request. Forty three residents confirmed that for more than twenty years they had walked these particular footpaths. Arrangements were now being made for ten of those residents to be formally interviewed to verify their statements. It was hoped that once this process had been completed, Durham County Council would determine the status of the current permissive footpaths.

Alderman Johnson stated that problems may have occurred due to opencast works, footpaths not being reinstated and being redesignated and not put on the Definitive Map. Preparations for the proposed solar farm may also have contributed to the stopping up of some of the footpaths.

Mrs Galloway was thanked for bringing this matter to the Parish Council's attention and requested to keep the Parish Council updated.

Community Centre

There was no Community Centre report.

The Parish Council were of the opinion that the Centre was a shining example of what could be achieved when the community, in conjunction with the Lottery Fund, Durham County Council and the Durham Foundation, worked together.
