36. Burnhope Cemetery

Discussion took place regarding the regulation of Burnhope Cemetery. To date there had been no regulation of burial plots within the cemetery. A copy of the proposed Rules and Regulations had been circulated to Members. It was hoped that adopting these new regulations would help improve safety in the cemetery, reduce grounds maintenance costs and generate additional income for the future of the cemetery.

After discussion the following was approved:-

- 1. Exclusive Right of Burial to be reduced to 50 years for future applications. Conditions of previously purchased plots (i.e. 99 years) to be honoured.
- 2. A grave selection fee be charged if the allocated plot is not accepted.
- 3. Kerbs No kerbs allowed from 5th September, 2025.
- 4. Solar Lights Solar lights only to be allowed on graves at Christmas time.
- 5. Interment Fees burial plots no change for method of claiming fees.
- 6. Interment Fees Ashes plots re-evaluation of how this fee is currently paid to be discussed with the grave digger before a decision is made.
- 7. Burial Records No records are available. A new Register of Burials has been purchased and burial records will be completed using information taken from headstones.
- 8. Burial Plots **Agreed** that row GR6, along the east wall of the cemetery, be re-designated as cremated remains plots.
- 9. Cemetery wall repairs to the north east corner of the cemetery wall have been carried out.
- 10. Cemetery extension Letters had been sent to the adjoining landowners on the 10th July and 23rd August, 2025 expressing the Council's interest in acquiring land for the expansion of the cemetery. To date there has been no response.

Agreed that with the above updates, the Rules and Regulations Handbook be adopted.
