Police Report

The following Police report was read out :-

- Cannabis plants recovered from a building in Consett
- One incident of anti social behaviour reported since last meeting of off road bikes in the area. A number of Section 59 warning signs have now been placed in Burnhope area. These warnings cover the Traffic 183 warning notice which are issued to those who are using vehicles in an anti social manner. If caught by the Police in these areas riding anti socially, the bikes can be seized.

The question was raised about the operation and monitoring of the CCTV cameras in the village. Enquiries to be made about their coverage.

The Burnhope Wheel had been printed and distributed throughout the village. Funding was available to continue to produce three, yearly issues.
